Nature of Services:

As a licensed therapist, I am trained, as with other classes of therapists, in the clinical assessment, diagnosis, and treatment of mental health disorders in individuals. As a Marriage & Family Therapist, I have also retained specialized training in the systemic treatment of individuals, couples, and families. The systemic approach to assessment, diagnostics, and treatment/therapy takes into consideration all persons and relational dynamics relevant to the client's therapy/treatment. However, this does not require that additional persons be involved in treatment. The decision on any persons needing to be included in therapy is made jointly with the client. Currently, the practice is offering individual, couples, and family therapy via telehealth.

Billing and Fees:

You may pay electronically via Square, Email, Apple Pay, or Cashapp or by consenting to manual card charging of your Debit/Credit/HSA/FSA Card. The fee for your service will be made known to you before the time of service and as part of your admit or onboarding process and is expected to be paid at end of

each session, before end of day (11:59PM) of service date, or according to your payment plan, as scheduled by yourself and myself. This practice does not currently accept insurance, though we can provide superbill documentation for you. However, you will be responsible for requesting such documentation and providing it to your insurance provider.

Ethics:

In the event that you are requesting psychotherapeutic services from Asha within clinical care or upon clinical consult, and Asha is unable to provide the services you require, she will provide information on referrals to other professionals trained to meet your needs. However, you will be responsible for choosing to move forward with those referrals, unless you have consented to Asha supporting you in facilitating your warm hand off to your next provider.

Sexual relations between therapists and their clients are never appropriate, and sexual relations will not occur between Asha and clients or any persons seen in a professional setting.

According to sound ethical practice at this time, professional duties will include delineation between modes of support. Specifically, no client or patient from any professional source of business or support from Asha will receive support from Asha as their licensed therapist and certified coach simultaneously. In effect, if you are agreeing to see Asha as your licensed therapist, it is important to know that though coaching interventions are commonly used within the practice of therapy, Asha will still only be your licensed therapist until, if applicable, such time when your therapy case is closed and you request professional support with Asha as a certified coach. With regards to certified coaching or consulting, Asha will only act as a client's certified coach or consultant, and therapeutic services will not and are not being performed via these services. While supporting you within these roles, Asha will also not agree to additionally take you on as a therapy client, effectively becoming your licensed therapist as well; the client must retain clinical behavioral health/behavioral health services from a different licensed provider.

Confidentiality:

If you are a therapy client, the information you share in therapy with Asha is generally considered confidential by state law. Additionally, it is considered privileged communications in a federal court. However, North Carolina courts do not recognize privilege. Therefore, the information you share in therapy can be subpoenaed through a court order for your progress notes. Further, Asha is mandated by law through "duties to warn" to breach confidentiality if she discovers: 1) you are threatening self-harm or suicide; 2) you are threatening to harm another or homicide; 3) a child has been or is being abused; 4) a vulnerable adult has been or is being abused.

Records Requests and Release:

If you are a therapy patient and wish your health information to be released from therapy to someone (e.g. an attorney, a physician, etc.), or for yourself, you will need to do the following:

- Reach out to Asha or the practice via written documentation, namely email:

- Request within your email what you would like released, to whom, and for what reason,
- Allow 3 business-days for a response,
- Confirm with Asha or admin, if needed, the details of your request and completion of your Release of Information form,
- Allow up to 30 business days for the practice to process your request,
- You will receive either confirmation of your request via email upon completion.
